## ORDINANCE NO. 13

## AN ORDINANCE RELATING TO AND DEFINING THE LIMITS OF HUNTER, IN MITCHELL COUNTY KANSAS.

BE IT ORDAINED BY THE MAYOR AND COUNCILMEN OF THE CITY OF HUNTER:

SECTION 1. The territory comprising the city of Hunter is as follows, to-wit: Beginning at the Northwest corner of the southwest quarter, of the southwest quarter of Section Twenty-Five, Township Nine, South, Range Ten, West of the Sixth Principal Meridian Mitchell county, Kansas, thence along the north line of the south half of the southwest quarter of said section Eighteen Hundred Sixty (1860) feet; thence south along a line parallel to the east line of said Southwest quarter of the Southwest quarter of Section Twenty-five, Thirteen Hundred Eighteen and one-tenth (1318.1) feet; thence west along the line between sections twenty-five and twenty-six, Five Hundred Twenty (520) feet to the guarter guarter corner, thence south along the east line of the Northwest quarter of section Thirty-six, Township Nine, South, Range Ten, West, Thirteen Hundred Twenty-six and Two-tenths (1326.2) feet to the southeast corner of said quarter guarter, thence west along the south line of said guarter guarter extended Thirteen Hundred Sixty (1360) feet to the west line of Main Street extended, thence north along the said line extended Six Hundred Sixteen and two-tenths (616.2) feet to the north line of B Street, extended West from Wagner's Addition to Hunter, Kansas, thence west along said north line of B Street, extended Five Hundred Twenty-seven and Five-tenths (527.5) feet to the west line extended of the alley between Thompson Street and Western Avenue in Thompson's Addition to Hunter, Kansas, thence North along the said extended west line of said alley Eleven Hundred Twenty (1120) feet to the west line of the Salina Northern Right of Way, thence in a Northwesterly direction along the west line of said Right-of-way Nineteen Hundred Fifty (1950) feet to the North line extended of Thompson's Addition to Hunter, Kansas, thence east along said North line of Thompson's Addition to the line between Section Twenty-six and Twenty-five. Township Nine, South, Range Ten, West Eighteen Hundred Fifteen (1815) feet, thence South along said section line to the place of beginning, Five Hundred Thirty-one and nine-tenths (531.9) feet.
