

ORDINANCE NO. 5

AN ORDINANCE PROVIDING FOR THE ISSUANCE OF LICENSES TO, AND PAYMENT OF LICENSE FEES BY OWNERS, MANAGERS OR PERSONS HAVING CHARGE OVER OR CONTROLLING MENAGERIES, CIRCUSES, STRIKING, LIFTING OR WEIGHING MACHINES, SHOOTING GALLERIES, BILLIARD AND POOL TABLES, BOWLING AND TENPIN ALLEYS, MERRY-GO-ROUNDS, AND MAGIC LANTERN AND MOVING PICTURE SHOWS.

BE IT ORDAINED BY THE MAYOR AND COUNCILMEN OF THE CITY OF HUNTER:

SECTION 1. Any person or company owning or managing any menagerie combined, which is conveyed from place to place by railroad, shall before giving any exhibition, performance or street parade in the city of Hunter apply to the city clerk and obtain a license permitting such show, exhibition or parade; the fee for which license shall be ten dollars for each exhibition or parade, or parade and exhibition.

SECTION 2. Any wagon show or circus or menagerie and circus combined not traveling by rail, shall before exhibiting in the city of Hunter, or parading upon the streets thereof, obtain from the city clerk a license for such exhibition, paying for the same the sum of five dollars.

SECTION 3. Any person owning managing, controlling or having charge of any side-show or circus, menagerie or other entertainments, or owning, managing, controlling or having charge of any jugglery, legerdemain, panorama or other performance not hereinbefore specifically mentioned, shall before giving such exhibition or performance apply to and obtain from the city clerk a license therefor, paying for such license the sum of five dollars for each day.

SECTION 4. Any person who shall operate any striking machine, nickel-in-the-slot machine, cane or knife rack, lung tester or electric battery or like exhibition or games within the said city of Hunter, shall before operating such machine or giving such exhibition or game, apply to and obtain from the city clerk a license therefor, which license shall be issued by the clerk upon the payment therefor at the rate of \$3.00 per day; provided, that this section shall not be considered as authorizing the issuance of any license to any person desiring to operate any gambling or lottery devices of any kind or description.

SECTION 5. That any person or company who shall operate a circular swing, propelled by steam or any other power, commonly called a "merry-go-round" shall, before commencing to operate such swing within the city of Hunter, first apply to and obtain from the city clerk a license therefrom and such license shall be issued upon the payment of the sum of \$2.00 per day for each and every day the same shall be operated, if a license is applied for and obtained from day to day; but if a license applied for and obtained for one or more weeks, the license shall be \$6.00 for each and every week the said swing shall be operated.

SECTION 6. Any person who shall have a temporary stand within the city of Hunter and who shall as such temporary stand offer for sale or sell any goods, wares, merchandise, fruit, confectionery, ice cream, lemonade, cigars, tobacco or other articles or drinks, on days of shows, fairs, holidays, public speaking, or public demonstrations, shall, before commencing so to sell, procure a license therefor of the city clerk, paying for such license the sum of \$1.00 to \$25.00 for each day.

SECTION 7. Any person owning or managing any theatrical company or troupe, or any troupe of minstrel or other troupe of performers or performer shall, before giving such exhibition obtain a license from the city clerk, paying for the same \$2.00 to \$15.00 for each exhibition.

SECTION 8. Any person owning or managing any concert or lecture, or exhibition of magic lantern, moving picture show, or any lantern show by which views are projected on canvass or screen, or any other exhibition or show where an admission fee is charged, shall, before giving such exhibition obtain from the city clerk a license, paying therefor the sum of \$2.00 to \$5.00 for each entertainment. Provided, that when it is made to appear to the mayor that the proceeds of any such exhibition are to be donated to any public, charitable or religious institution he may, if he deems it proper, remit such license tax: And provided further, that all scientific and literary lectures and entertainments shall be exempt from taxation, as well also, as concerts and musical or other entertainments given by the citizens of the city, exclusively.

SECTION 9. That it shall be unlawful for any person or company owning, managing, controlling, maintaining or having in charge any opera house or public dancing hall within the city of Hunter, wherein any exhibition, concert, opera, show or other entertainment is given without first taking out and having a license therefor from the city clerk, signed and issued in the manner prescribed by the laws of the state of Kansas and the ordinances of the city of Hunter. That before any person, persons or company shall be given a license to keep, maintain or operate such opera house or dancing hall as described in this section, such person, persons or company shall pay for such license the sum of \$1.50 per month or \$10.00 per year.

SECTION 10. That it shall be unlawful to set up, keep or maintain within the city of Hunter, Kansas, any shooting gallery in which a fee is charged or paid for shooting at targets or marks or other objects for the purpose of amusement, without first taking out and having a license therefor from the city clerk, signed and issued in the manner prescribed by the laws of the state of Kansas and the ordinances of the city of Hunter. That before any person or persons shall be given a license to set up, keep or maintain any shooting gallery as described in this section, such person shall pay for such license the sum of \$1.00 to \$5.00 per day.

SECTION 11. That it shall be unlawful to set up, keep or maintain within the city of Hunter, Kansas, any billiard table, pool table, pigeon-hole tables, or any other similar table or device on which games are played or which a fee is charged for playing thereon, or any tenpin alley or bowling alley, without first taking out and having a license therefor from the city clerk, signed and issued in the manner prescribed by the laws of the state of Kansas, and the ordinances of the city of Hunter.

SECTION 12. That before any person or persons shall be granted a license to keep or maintain any billiard table, pool table, pigeon-hole table or other similar table or device, such person or persons shall pay for such license as follows: For each of such tables the sum of \$50.00 for 1st table \$30.00 for the 2nd table, \$5.00 for each additional table, per year. And before any person or persons shall be granted a license to keep and maintain a bowling alley or ten-pin alley, such person or persons shall pay for such license the sum of \$60.00 per year.

SECTION 13. Any person who shall violate any of the provisions of this ordinance shall, upon conviction thereof, be fined in the sum of not less than \$5.00 and not more than \$50.00, and shall be committed to the city prison until such fine and costs of prosecution are paid.

SECTION 14. This ordinance shall take effect and be in force from and after its publication in the official city paper.
